Technical changes to the Performance Indicators PITG 12/05

Issue

- 1. The questions on the 2011/12 DLHE questionnaire have been modified and as a result, there was a need for the concept of activity to be redefined for use in HESA publications. This will also impact on the employment indicators.
- 2. There have been changes to the qualifications included in the UCAS tariff which will impact on the benchmarks.

Recommendations

- 3. PITG to approve using the equivalent, under the new derivation of activity, of the old activity categories A-F to define the employment indicators for 2011/12.
- 4. PITG to approve the continued use of XTARIFF, with the modifications outlined below, in the derivation of the benchmarks and to treat the new BTEC qualifications with (B) BTEC and (BE) BTEC National in Early Years.

Employment indicators discussion

- 5. The 2011/12 DLHE questionnaire was modified and question 1 now asks what the leaver was doing on the reference date. Multiple activities may be ticked and the "most important" activity must be highlighted.
- Previously, the leaver was asked in two separate questions which activity (only one
 may be ticked) best describes their employment circumstance on the reference date
 and if the leaver was also involved in any full-time or part-time study (study
 circumstance).
- 7. Prior to 2011/12, activity was derived using the following matrix of employment circumstances and study circumstances:

- 9. The employment indicator was defined as the proportion of leavers in activity categories A to E out of those in activity categories A to F.
- 10. Following consultation with a review group consisting of statutory customers and experts, the concept of activity was redefined for 2011/12 based on answers from the first question of the survey only. Similar colours and numbering have been used in this paper to highlight an approximate mapping between the old and new activity categories, although the content of these groups is likely to differ.

- 11. Proposal to create the 2011/12 employment indicator by taking the proportion in categories A to E out of those in categories A to F.
- 12. Since the new activity categories put an emphasis on "most important activity" which was not previously taken into account, the content of the categories are likely to differ, although the extent of this is unlikely to be known until the collection has taken place.

Tariff changes discussion

- 13. The table below provides a list of the new qualifications which have been added to the UCAS tariff for 2011/12 and included in the derived field XTARIFF. The final coding frame for BTECs is still to be confirmed and may differ from below, but UCAS and HESA plan to issue a joint statement when a decision has been finalised.
- 14. In addition and following institutional comment, the previously excluded (FA) Diploma in Foundation Studies (Art and Design), has been included in the tariff calculation (XTARIFF) for 2011/12. It was previously excluded as FA qualifications are not ABL qualifications and therefore do not available electronically to institutions, even though they are valid QUALTYPE codes.
- 15. On advice from UCAS, where a (FD) Financial Services (Diploma) qualification is present with a (FS) Financial Services (Certificate) qualification, only the points from the Certificate are retained in XTARIFF.
